4. The employees availing Diagnostic Services/Investigation **shall make payment** as per prevailing CGHS rate or less if so charged. **The bills will be reimbursed** by WCL as per rule.

5. **The Report in detail shall be given on the letter head** of the Diagnostic Center as per specification in EOI..

6. Any or all Diagnostic Centres can be depanelled without assigning any reasons thereof.

7. The Diagnostic Center empanelled may be inspected by authorized person of Medical Department of WCL from time to time and depanelment clause can be attracted if the T&C/Criteria(s) of EOI is/are not found in order.

8. All other terms and conditions are as accepted by the concerned Diagnostic Centers mentioned in the expression of interest and other standing rules of WCL applicable from time to time
