Notice to FSA Consumers

Sub: Submission of Annual documents for the year 2015-16 with regards to end use of coal.

As per the provision of New Coal Distribution policy (NCDP), verification of end use of coal by erstwhile Non Core Sector Consumers is to be done to ensure discipline and economy of coal used. Regarding submission of documents a notice had already been issued vide notice no NGP/WCL/ S&M/RS/599 dated 19.10.2016.
